LEAVING A GIFT IN YOUR WILL OR TRUST

Leaving a gift to USA for UNFPA in your will or trust is an easy way to provide for the people and causes dear to you. It's simple, easy, and powerful. Your will or trust specifies how you would like your assets distributed after your lifetime. You can designate a specific dollar amount, asset, or percentage of your estate for USA for UNFPA.

To leave a gift to USA for UNFPA, just share this sample language with your attorney:

"I give to USA for UNFPA, Federal Tax ID Number 13-3996346, or its successor organization [dollar amount, asset, or percentage] for its [unrestricted charitable use and purpose] or [its work in issue area/geographic region]."

NAMING USA FOR UNFPA AS A BENEFICIARY

There are many financial accounts that allow you to name a person or organization to receive your assets after your lifetime—it's called a beneficiary designation:

- IRA, 401(k), or other qualified retirement plan
- Bank account (checking, savings, money market, etc.)
- Life insurance policy
- Brokerage account
- Certificate of deposit
- Donor-Advised Fund

1 To name USA for UNFPA as a beneficiary, follow these easy steps:

Request a beneficiary form from your bank or plan administrator or find one in your online account. This form—not your will—determines how these assets are distributed after your lifetime.

2 Write in USA for UNFPA on the form, using the following information:
